1. Amendments to charges and rates

EMEA (Europe, Middle East & Africa)

DAL - adjusted Terminal Handling Charges in Europe

Effective January 1st. 2012 the shipping line DAL announced adjusted **Terminal Handling Charges** as follows:

MSC - adjusted Terminal Handling Charges in Europe

With effect from 15.02.2012 MSC adjusted the **THC** for the ports in Bremerhaven and Hamburg. Import and Exportcontainer will be charged as follows:

DV/HC EUR 210.00 per Container
Reefer EUR 320.00 per Container
OOG EUR 380.00 (unchanged)

OOG (chains) EUR 675.00

Effective March 1st, 2012 the Terminal Handling Charges in Rotterdam and Antwerp will be changed as follows:

Rotterdam EUR 195.00 per TEU Antwerp EUR 160.00 per TEU



Maersk - Reduction Documentation Amendment FEE

Shipping line Maersk announced the reduction of the **Documentation Amendment Fee** for all shipments from USD 50.00 per B/L to USD 25.00 per B/L - effective March 1st, 2012.

Maersk Line - Peak Season Surcharge in Mombasa

Due to risen volumes and a huge port congestion of the port in Mombasa Maersk Line implemented a **Peak Season Surcharge** to the amount of USD 150.00 per TEU. The surcharge has been charged since 01.01.2012.

Maersk Line - Congestion Surcharge in Dar-es-Salaam

Maersk Line announced - with effect from 01.01.2012 - the implementation of a **congestion surcharge** for all shipments to Dar-es-Salaam to the amount of USD 300.00 / 40´Container. This was necessary due to the difficult circumstances and will be removed as soon as the situation will permanently recover.

Maersk Line - Congestion Surcharge Westafrika

Since January 1st, 2012 Maersk Line adapted the amount of the invoiced **Congestion Charges** for shipments to West Africa. This concerns the following ports: Conakry, Guinea

EUR 360.00 - since 01.01.2012 EUR 200.00 per TEU

Matadi, Kongo

EUR 1.250.00 - since 01.01.2012 EUR 1.500.00 per TEU

Turkey - Maersk Line - Cargo Data Declaration charge (CDD)

Concerning the new regulatories for imports to Turkey Maersk Line implemented a **Cargo Data Declaration Charge** (CDD) to the amount of USD 25.00 per B/L. The surcharge has been applicable since February 1st 2012.

Turkey - CMA CGM - Custom Documentation Charge

CMA CGM has – due to changed import formalities for shipments to Turkey – implemented a **Custom Documentation Charge** with effect from 01.122012. It will be charged in the amount of USD 25.00 per B/L for containerized cargo USD 10.00 per B/L for non containerized cargo (including trailers)

Turkey - MSC - Cargo Data Declaration Charge

With effect from 01.02.2012 MSC implemented a $\pmb{\text{Cargo Data Declaration Charge}}$ – in accordance to the new import regulations for

shipping line Maersk announced a **general rate increase** - effective January 15th, 2012. The rate increase is about

Hapag Lloyd - Surcharge adjustment for Middle East

The shipping line Hapag Lloyd has changed several **surcharges** for shipments to Middle East effective February 1st, 2012:

MSC - Congestion Surcharge for Poti

Due to the port congestion at Poti which is causing considerable delays in operations, MSC has decided to implement a **congestion surcharge** of USD 200.00 per TEU - with effect from 1_{st} February 2012.

The surcharge will be charged until further notice.

Asia Pacific

Safmarine - Withdrawn of Congestion Surcharge Chennai

Safmarine recently informed to withdraw the **Congestion Surcharge** for the port of Chennai with effect from 01.02.2012. Reason is the positive development and significant improvement of operation at port of Chennai.

CMA CGM - Terminal Security Charge in USA

The shipping line CMA CGM announced that with effect from 20.0.12012 the **terminal security charges** for the ports of Baltimore, Savannah, New Orleans and Houston have been changed as follows:

CMA CGM - Emergency fuel surcharge for imports ex US

Effective March 1st, 2012 CMA CGM announced the implementation of an **Emergency Fuel Surcharge** valid for USA Exports to Europe. The surcharge amount will be USD 221.00 per 20´Container and USD 442.00 per 40´Container.

CMA CGM - adaption of surcharges for North America

The shipping line CMA CGM has changed their **Bunker Adjustment Factor** for North America as follows. The adjustment is valid since February 2012

MSC - Drop Off Fee in Puerto Cabello, Venezuela

Maersk Line announced the increase of the **Drop Off Fee** for Puerto Cabello, Venezuela to USD 410.00 per Container. This adjustment is valid with immediately effect.

Hapag Lloyd - Adjustment of surcharges for North America

MSC - Terminal Handling Charges Dominican Republic

Shipping line MSC announced the adjustment of **Terminal Handling Charges** in Caucedo , Rio Haina. This change took effect on February 1st 2012 as follows: to/from all origin/destination ports except USA ports: USD 135 per container to/from origin/destination USA ports: USD 75 per container (unchanged)

Hapag Lloyd - adapted surcharges South America

2. Liner services

EMEA (Europe, Middle East & Africa)

MAERSK Line - Tin Can

As per previous newsletters information the terminal of Lagos is often highly congested. This leads to delays in operating of vessels and containers. In this account Maersk Line adjusted its service and changed (from Lagos) to Tin Can. First vessel of service MEW1- after changing - is the "Michaela S" who will call the PTML Terminal.

Asia Pacific

Congestion at port of Colcata

Shipping line Safmarine informed that due to backlog of containers destined for Colcata there are **huge delays** of operations in the port of Colombo – the average delay is about 3-4 weeks.



New alliance for Far East

Six leading shipping lines of the Grand and New World alliance founded a new alliance in Asia-Europe-service. Following shipping lines are part of it: APL, Hapag-Lloyd, Hyundai Merchant Marine, Mitsui O.S.K Lines, Nippon Yusen Kaisha and Orient Overseas Container Line.

Starting in April 2012 the alliance will operate seven services between Asia and Europe and Asia and Mediterranean:

South America | Central America

Maersk Line - new Europe - Andean Service

Maersk Line is introducing a new **direct Service** ex Europe to Central- and South America. The port rotation will be as follows: Rotterdam (NL) - Tilbury (UK) - Hamburg (G) - Antwerp (B)- Cartagena (CO) - Manzanillo (PA) - Balboa (PA) - Guayaquil (EC) - Callao (PE) - St Antonio (Chile)

MSC South America East Coast Service

Effective January 2012 shipping line MSC adjust the port rotation of their **South America East-coast Service** (SAEC String 1) to:

Antwerp - Rotterdam - Hamburg - Bremerhaven - Le Havre - Sines - Rio de Janeiro - Santos - Montevideo - Buenos Aires - Navegantes - Rio Grande - Itaquai - Antwerp

Below please find the destinations in transshipment ex according ports:

- Via Navegantes: Rosario, Zarate
- Via Buenos Aires: Santa Fe, Las Palmas
- Via Montevideo: Fenix, Terport, Caacupemi

MSC South America West Coast Service

MSC announced the cancelation of the port of **Santa Marta** in their South America West Coast service with immediate effect. Only bookings via Cartagena will be accepted.

Equally to Santa Marta the call of the port of **San Francisco del Sul** is cancelled with immediate effect -bookings are only accepted via Navegantes or Itapoa.

3. Regulations and authorities announcements

Turkey - new regulations for import manifest

The Turkish Authority announced changed regulations for imports to Turkey.

This contains the sending of complete and correct shipping instructions to the shipping line - latest 48hours prior to vessel arriving at POL. The instructions have to contain per description of goods the 6-digits HS code. Furthermore the TAX ID / Tax number of the consignees must be shown. The regulation is applicable since January 1st 2012.

Qatar - new customs regulations

The customs regulations of Qatar has implemented a new Qatar Customs Clearance Single Window (QCCSW) System with effect from 01.01.2012. Since then it is mandatory to furnish the final or end consignee's details while filing the cargo manifest online. Any cargo manifest reading a Freight Forwarder details in "consignee" column will be subject to rejection by the Customs Authorities.

The QCCSW also demands each and every consignee to register themselves online for smooth clearance of their shipments.

US shipments - New High Security Seal Standards

The shipping line Maersk is once again pointing out that effective 01st March 2012, the current International Organization for Standardization (ISO) mechanical seal standard (ISA/PAS 17712) will be replaced with a new ISO standard - **ISO 17712:2010**. This applies for seals on all containers exported or imported from/into the USA.



4. Special information

Strike Action at port of Rotterdam

Due to unannounced work stoppages at the APM Terminal Rotterdam during the last few days, shipping line Maersk is expecting possible new strike actions. As a precaution Maersk Line has activated contingency measures to minimize delays for week 6 -9. Until now an end of the conflict is unforeseeable and the further developments open.

In case bookings are placed on the affected vessels, you will be contacted by your contact person as you are accustomed to.

Certificate of conformity Kenya, Tansania, Iraq, Botswana, Indonesia by Bureau Veritas

The Bureau Veritas informed about the following changes:

Kenya - Bureau Veritas has been announced for the execution of conformity inspections (Pre-export Verification of Conformity) for exports to Kenya by the Kenyan national standards institute Bureau of Standards (**KEBS**).

The conformance program includes beyond others the following product groups:

- Foodstuff and related products
- Chemical and related products
- Textiles and consumer goods
- Building materials and related products
- Mechanic and electronic products

Tanzania - Bureau Veritas has been announced for the execution of conformity inspections by the TBS (Tanzanian Bureau of Standards)

Following product groups are subject to the CoC program:

- toys and sporting goods
- electrics and electronically articles
- vehicles and vehicle parts
- chemical products
- mechanical components
- paper and office supplies
- furniture
- safety requirements



- Foodstuff and foodstuff raw materials
- used products

Iraq / Kurdistan

The standard institution (KSQCA) of the autonomic region Kurdistan has adapted the VOC program of the COSQO with effect from 15.01.2012.

Latest April 15th 2012 the certificate of conformity (COC) has to be issued for all cargo – in the meantime the exporteur can contract out of the KSQCA for individual shipments. The border control will start 15.0.2012.

The KSQCA will accept - in opposition to COSQC international product standards in conjunction with the compliance of national deviations.

Botswana

The BOBS (Botswana Bureau of Standards) has assigned the Bureau Veritas for the issuing of the certifications according to SIR (Implementation of Standards Import Inspection Regulation).

Indonesia

The KSO Sucofinde Surveyor Indonesia (KSO SCISI) has assigned the Bureau Veritas with the conformity inspections for exports to Indonesia.
