On January 1, 2020 Incoterms® 2020 the newest edition of the Incoterms® rules will be released in order to prepare business for the next century of global trade. International Chamber of Commerce (ICC) presents a specific guidance to individuals participating in the daily import and export of global trade.

Incoterms® 2020 addresses on security requirements, insurance coverage, financing and changes to trading practice and were restructured, updated and supplemented with practical operational advice.

With reference to the Incoterms® rules in a contract for the sale of goods, the respective obligations of the parties with regard to risk, costs, transport agreement and customs clearance are clearly defined.

HS Code mandatory for destination Russia

Please note that 6 digit HS code (Harmonized Code) will be mandatory information requested on submission of shipping instructions for all import bookings to all Russian ports, effective date will be as of 15th December 2019.

Shipping Instructions received without or incomplete WCO (World Customs Organization) HS6-digit code will not be processed. These shipping instructions will be rejected, requesting customer to resend the shipping instructions with complete information. In case of multiple commodities HS codes for all the Commodities needs to be listed clearly as well.

Peak Season Surcharge for Reefer containers

Please note that several shipping companies have already announced a Peak Season Surcharge for Reefer containers to the Far East. Please ask for the current surcharges at time of booking.

Note: In clause 23 the ADSp 2017 deviates from the statutory liability limitation in section 431 German Commercial Code (HGB) by limiting the liability for multimodal transportation with the involvement of sea carriage and an unknown damage location to 2 SDR/kg and, for the rest, the customary liability limitation of 8.33 SDR/kg additionally to Euro 1.25 million per damage claim and Euro 2.5 million per damage event, but not less than 2 SDR/kg.

Outside the scope of the ADSp our "[Terms and Conditions regarding the limitation of our liability outside the scope of application of the ADSp](#)" apply.
